

SCHEWELS HOME \$60,000 REST-TEST SWEEPSTAKES

OFFICIAL RULES. NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

- HOW TO ENTER:** Beginning 1/22/26 through 4/30/26 (“**Promotion Period**”), visit a participating Schewels Home store in the states of North Carolina, Virginia and West Virginia, take a “Rest-Test” on any mattress in-store and then receive a **Schewels Home \$60,000 Rest-Test Sweepstakes** (“**Sweepstakes**”) game piece (“**Game Piece**”) from a Schewels Home store representative at the conclusion of your Test-Rest experience. Each Game Piece will contain a ten (10) character unique code (“**Code**”). The Code will be printed in two (2) locations on the Game Piece. The Schewels Home store representative will provide each entrant with a portion of the Game Piece containing the Code for the entrant to retain. The other portion of the Game Piece will be retained by the participating store and entered into the Sweepstakes. At the conclusion of the Promotion Period, one (1) \$1,000 winning Code will be randomly drawn for each of the fifty-two (52) participating stores from all eligible entries received for the respective store. Additionally, all eligible entries received for all participating stores will be included into a random drawing to select one (1) \$8,000 Grand Prize-winning Code from all eligible entries received for the Promotion Period. Entrants will then check the Schewels Home website at www.schewelshomeresttest.com or visit a participating Schewels Home store to check to see if the randomly selected Codes match the Code on their Game Piece. If an entrant possesses a Game Piece that contains a winning Code, he/she must visit the participating store where they received their Game Piece in order to claim their prize. Further details on the random drawing, prize claim process, prizes and other promotion information is described below. Limit one (1) Game Piece per person, per store visit. A “store visit” is defined as a 24-hour period from when an individual physically visits a participating Schewels Home store. Additionally, one (1) \$8,000 Grand Prize-winning Code for the entire Sweepstakes will be randomly selected from all eligible entries received from all participating stores during the Promotion Period on or about 5/6/26 by an independent third party of the Sponsor or its designee, whose decisions are final.
- TO CLAIM A PRIZE:** For prize claim and verification, beginning on or about 5/9/26 go online at www.schewelshomeresttest.com or visit a participating Schewels Home store to check the Code on your Game Piece with the winning Codes that were randomly selected for each participating store and for the Grand Prize. Potential prize winners will be the entrant of a Game Piece containing a winning Code that is randomly selected as a winning Code, subject to verification. Potential winners will be required to visit the participating Schewels Home store where they received their Game Piece to claim a prize. The original Game Piece and winning Code possessed by a potential winner must be verified by store management personnel at the participating store where the potential winner received their Game Piece. **Prize claims must be presented in-person by a potential winner by 6/18/26 or prize will be forfeited.** Sponsor shall have no liability for any prize claim that is not received by the prize claim deadline at a participating store by a potential winner for any reason. Each Store Prize winner will receive \$1,000 (to be awarded in the form of a check to the winner) / ARV \$1,000 ea. winner. Total ARV of all prizes \$60,000. Odds of winning the Grand Prize depend on the total number eligible entries received from all participating stores during the Promotion Period. Odds of winning a Store Prize depend on the total number of eligible entries received for each respective store during the Promotion Period. Unclaimed prizes will not be awarded.
